

TOWN OF FIFIELD SPECIAL BOARD MEETING
MINUTES OF May 10, 2017

ROLL CALL: Meeting was brought to order on May 10, 2017 at 4:00 p.m. at the Fifield Town Hall. Present: K. Balzar, J. Hintz, and J. Wierzba. Also present S. Putnam and 4 others.

WEIGHT LIMIT POSTINGS FOR W. CENTRAL AVE., ELM ST., ASH ST., CHERRY ST., OLD 13 RD., AND DIVINE RAPIDS RD WHILE THE HWY 182 BRIDGE IN THE CITY OF PARK FALLS IS BEING REPLACED: Motion (Hintz, Wierzba) to post weight limits of 25,000 pounds on W. Central Avenue north of Hwy 70, Elm, Ash and Cherry Streets, Old 13 Rd from W. Central Ave. north to the town line, and Divine Rapids Rd while the Hwy 182 Bridge in the City of Park Falls is being replaced. Motion approved, voice vote (3, 0). The clerk will run a notice of the postings in the May 18th and May 25th issues of the Price County Review.

TODD'S REDI-MIX REQUEST FOR A WEIGHT LIMIT EXEMPTION PERMIT FOR W. CENTRAL AND OLD 13 RD WHILE THE HWY 182 BRIDGE IN THE CITY OF PARK FALLS IS BEING REPLACED: M. Flynn from Todd's Redi-Mix Concrete and J. Felhofer, Project Manager for Pheifer Bros. Construction were present to request an exemption to the weight limits on W. Central Ave. and Old 13 Rd because of a timing issue. Todd's Redi-Mix is hauling the concrete for the bridge replacement project and they have a 90 minute time frame from when it is mixed to when it is poured. The request is only for the cement trucks hauling for this project. The State of Wisconsin monitors closely the condition of the cement. Because of the scheduled road work on W. Central and Old 13 Rd, the board will include Divine Rapids Rd in the request as an alternate route. They asked that Todd's Redi-Mix and Pheifer Bros. Construction keep in communication with John S. Olynick as to when Olynick's road work would warrant the use of the alternate route. **Motion (Hintz, Wierzba) to honor Todd's Redi-Mix request for a weight limit exemption permit for W. Central Ave., Old 13 Rd and Divine Rapids Rd while the Hwy 182 Bridge in the City of Park Falls is being replaced. Roll call vote: Hintz – aye, Wierzba – aye, Balzar – aye. Motion approved.**

ADJOURN: Motion at 4:20 P.m. (Wierzba, Hintz) to adjourn. Motion approved, voice vote (3, 0).
