#### **CLERK/TREASURER:**

REPORT: Treasurers Financial Report for December and YTD were reviewed and accepted

ARPA: Guidelines for American Recovery Plan Act funds have been changed to include general expenses; as updates on reporting come from WTA this will be further discussed on spending plans at a future meeting

## FIRE DEPARTMENTS:

Board Review of Fire Department:

With the assistance of Atty. Bryce Schoenborn the Board has determined for Fire Department #2

- Matt Langenhahn will remain Fire Chief until further notice
- There will be a special meeting 1/25/2022 for the Board to appoint positions for Assistant Chief and Captain

There was additional questions and answers by Atty. Schoenborn regarding past practice and documentation in regards to Fire Departments and primarily the election process

- An updated Ordinance, as well as the existing 2009 By Laws will be reviewed, revised and drafted by Atty. Schoenborn and the Board for both Fire Departments
- A Committee will be established by the Board to work on Fifield's Fire Department's Policy and Procedure Manual, this will start following the By Law revision completion
- Both Fire Departments will be expected to take proper minutes and submit them to the Board for inclusion in the Board Meetings, as well as written fire reports monthly

Fire #1 reported four EMR calls, with no fire calls and Fire #2 reported two EMR calls for the previous month
