

# **TOWN OF FIFIELD REGULAR BOARD MEETING**

## **Minutes of March 15th, 2022**

The meeting was brought to order on March 15th, 2022 at 6:00pm at the Fifield Town Hall

After this last ice storm they have been busy sanding the roads; also worked on frozen culvert between two businesses on Balsam St., had a logging company move in to start cutting back on Cy's Drive, this will be on hold until after the Special Meeting has taken place. Informed the Board that the price of culverts is going up, this will directly impact Cys Drive Project.
