## **TOWN CREW REPORT:**

Superintendent T.Fleming reported they are still testing the ECM part on the 2015 truck to see if that solves the quitting problem, they also replaced a broken spring on this truck. The furnance quit in the town shop, they got it going again, further repairs or replacing will be on the February meeting agenda, T. Fleming talked with USDA Forest Service regarding closing Riley Creek road and a partial of Gates Lake road during this spring break up, we have done so in the past.
