## TOWN OF FIFIELD REGULAR BOARD MEETING MINUTES November 18, 2025, at 6:15 p.m.

**VERIFICATION OF POSTING:** Clerk verified the public postings.

**PUBLIC COMMENT:** There were none.

**APPROVE MEETING MINUTES:** Minutes of November 4, 2025, were presented for review and approval. Motion made by David Ebert and seconded by John Schroeder to approve. VV 3-0.

**CEMETERY FINANCIALS/REPORT:** Financials were submitted for review. There was a change in the Wisconsin law about injury caused in a cemetery. Contact will be made with the insurance company to review the Towns coverage.

<u>CLERK/TREASURER REPORT:</u> Clerk reported tax bill stuffers and letter to residents about snowplowing were completed. Price County Tax Collection Agreement was signed by Chairman Felch and will be returned along with the payment. The Board will review outlook on tax collections in the future.

**FIRE DEPARTMENTS:** Fire Dept #1 reported they responded to 1 fire call and 6 EMS calls. They are in the process of hiring 1 new firefighter. Fire Dept #2 reported they responded to 1 EMS call.

<u>TOWN CREW REPORT:</u> Town Crew Supervisor reported that equipment is set up and ready for the winter. A new sign will be ordered and put up for Fender Bender Lane for safety concern purposes. Chairman Felch asked if it was necessary to have an agreement with Worchester Township for work on the town line. Town Crew Supervisor didn't feel that it was needed. Information was given about what projects will be worked on in the next couple of weeks by the Town Crew.

**TRANSFER SITES REPORT:** Town Crew Supervisor found a merchant to take batteries to for recycling at no charge.

APPROVAL OF UNION CONTRACT: Contracts were presented to The Board for signatures and will be returned.

**SNO-DROVERS AGREEMENT:** Agreement was signed by the Town Board and Sno-Drovers President. Adjustments were made to language in Sections 3 and 13. Section 3 should be a 3% increase each year to the lease agreement. The increase in the amount was paid in full for the 5-year term of the lease. For the remaining terms only lease and utilities amount are due. Section 13 should be no increase over the term of the agreement for utilities. Full payment amount of 2025 lease agreement and utilities were received.

**BAY AREA RURAL TRANSIT:** Representative from Price County updated The Board about what is offered to residents with their services. Information was shared about grants received and other municipalities' contributions to help support this project for the community. A motion was made by John Schroeder and seconded by David Ebert to contribute and donate \$1500 in January 2026. VV3-0

**CORRESPONDENCE:** Price County Highway Department informed about Tuscobia trail closure for 3 days.

**ADJOURN:** Motion made by David Ebert and seconded by John Schroeder to adjourn the meeting at 7:10 p.m.
