

**TOWN OF FIFIELD
REGULAR BOARD MEETING MINUTES
December 16, 2025, at 6:00 p.m.**

CALL TO ORDER: Chairman Felch called the meeting to order on December 16, 2025, at 6:00 p.m. at the Fifield Town Hall. Pledge of Allegiance was recited.

ROLL CALL: Present: William Felch, John Schroeder, David Ebert, Angie Richardson, Ted Fleming, and approximately 6 public attendees.

VERIFICATION OF POSTING: Clerk verified the public postings.

PUBLIC COMMENT: There were none.

APPROVE MEETING MINUTES: Minutes of December 2, 2025, and December 10, 2025, were presented for review and approval. Motion made by John Schroeder and seconded by David Ebert to approve. VV 3-0.

CEMETERY FINANCIALS/REPORT: Financials were submitted for review.

CLERK/TREASURER REPORT: The Clerk asked for approval to retain Kelly Kleinschmidt and Judy Reas as Deputy Clerk/Treasurers. A motion was made by David Ebert and seconded by John Schroeder to approve. VV 3-0.

TOWN CREW REPORT: Christmas decorations have been put up. There were some issues with power drops on light poles, but they have been fixed for this season. Due to heavy snow fall there are leaning trees that will be cleaned up in the spring. Sign at Fender Bender Lane has been installed. The Town Crew will continue with winter road maintenance and as weather allows start to work on a turnaround on North Bay Road. The Crew Supervisor will be buying a Blower that was demoed for removal of leaves and debris from gravel roads. This blower will have multiple purposes. A motion was made by David Ebert and seconded by John Schroeder to approve. VV 3-0. An ARIP grant was applied for the purpose of Hicks Landing Road improvements with the state. They should hear in the spring if they're approved.

TRANSFER SITES REPORT: It was brought to The Boards attention that July 4, 2026, is on a Saturday. It will be decided in the future if the sites are open that day.

FIRE DEPARTMENTS: Fire Department #1 reported the calls they responded to. FFFI also gave a donation to pay for radios and air tanks that were purchased for the department. Fire Department #2 reported the calls they responded to and about repairs that will be needed for their engine truck due to leaking fluids.

CORRESPONDENCE. There was none.
